**ORDINANCE OF THE TOWNSHIP OF WATERFORD AUTHORIZING
A DIRECT SERVICE PAYMENT AGREEMENT BETWEEN THE
TOWNSHIP OF WATERFORD AND ARCHWAY PROGRAMS**

WHEREAS, Archway programs (“Archway”) is a non-profit corporation of the State of New Jersey with its principal office at 280 Jackson Road, Waterford, NJ 08004; and

WHEREAS, Archway operates and conducts an educational facility in the Township of Waterford which consists of several acres of buildings, recreational areas and other facilities; and

WHEREAS, as a non-profit corporation Archway is not subject to real property taxation pursuant to New Jersey Statutes as provided; and

WHEREAS, Archway in a spirit of cooperation with the Township of Waterford has negotiated an Agreement to make voluntary payments to the Township in the form of “Direct Service Payment Agreement” in recognition of its responsibility to bear a portion to the public burden of taxation, which Agreement is attached hereto and incorporated by reference herein.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of Township of Waterford, County of Camden, and State of New Jersey as follows:

SECTION 1. The Township of Waterford hereby authorizes and approves the attached Direct Service Payment Agreement with Archway Programs for the receipt of monetary contributions to the Township to be utilized in the same manner as tax revenues received by the Township.

SECTION 2. That the Mayor and Municipal Clerk are hereby authorized to execute said Agreement on behalf of the Township of Waterford.

SECTION 3. All Ordinances or parts of Ordinances inconsistent with this Ordinance, are hereby repealed to the extent of such inconsistency only.

SECTION 4. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 5. This Ordinance shall take effect after final adoption and publication as required by law.
