ORDINANCE NO. 2018-11

ORDINANCE AMENDING CHAPTER 201 OF THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED "PARKS, PLAYGROUNDS AND RECREATION AREAS"

WHEREAS, on October 11, 2017 the Township of Waterford amended Chapter 201 of the Code of the Township of Waterford captioned "Parks, Playgrounds and Recreation Areas" Section 4.1 to include a new Fee Schedule; and

WHEREAS, as a result of further review, a further Amendment is required to Section 4.1 to clarify the previously adopted Amendment.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

Section 1. Chapter 201 of the Code of the Township of Waterford captioned "Parks, Playgrounds and Recreation Areas," Section 4.1 is hereby amended as follows for clarification purposes:

The caption of Section 4.1 should be revised to read:

Fee Schedule; Certificates of Insurance

Section 4.1 Paragraph A is amended to read:

A. Fee Schedule. Persons, groups and/or athletic teams not part of the Waterford Township Athletic Association or Atco Lions Football or the Waterford Township Cheerleading Association shall be required to pay fees in accordance with the Schedule attached hereto and incorporated by reference herein. Said fees shall be paid with the filing of the application for use of any park, playground and/or recreation facility owned by the Township of Waterford. These fees shall not be included in Chapter 124 of the Township Code captioned "Fees."

Section 2. All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

Section 3. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

Section 4. This Ordinance shall take effect after final adoption and publication as required by law.
