**ORDINANCE NO. 2018-3**

**ORDINANCE OF THE TOWNSHIP OF WATERFORD, COUNTY OF CAMDEN, STATE OF NEW JERSEY AMENDING CHAPTER 230 OF THE TOWNSHIP CODE PROHIBITING SMOKING IN ALL PUBLIC BUILDINGS AND ALL PUBLIC PROPERTY OWNED OR LEASED BY THE TOWNSHIP**

**WHEREAS**, Chapter 230 of the Waterford Township Code established regulations prohibiting smoking in all public buildings and on all public property owned or leased by the Township; and

**WHREAS**, it has been determined necessary to amend Chapter 230 to further identify all type of tobacco products and to increase the penalties for violation of the regulations.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

**Section 1.** Section 2 of Chapter 230 captioned “Definitions” shall be amended to include a new definition captioned “Tobacco Products” and which states as follows:

“Tobacco Product – Cigarette, cigar, smokeless tobacco to include snuff, chewing tobacco or any substance that contains tobacco.”

**Section 2.** Chapter 6 of Chapter 230 captioned “Penalties” shall be amended to read as follows:

“Penalties - Any person violating the provisions of this Chapter shall, upon conviction thereof, pay a penalty of One Hundred (\$100.00) Dollars for a first offense and a penalty of Two Hundred (\$200.00) Dollars for each subsequent offense.”

**Section 3.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

**Section 4.** All Ordinances or parts of Ordinances inconsistent with this Ordinance, are hereby repealed to the extent of such inconsistency only.

**Section 5.** This Ordinance shall take effect after final adoption and publication as required by law.
