ORDINANCE AMENDING ORDINANCE 2012-7 CHANGING THE RATES FOR SANITARY SEWER AND WATER SERVICES FOR THE TOWNSHIP OF WATERFORD

BE IT ORDAINED, by the Township Committee of the Township of Waterford that Ordinance 2012-7 is hereby amended to change Sanitary Sewer Rates effective July 1, 2018 and Water Rates effective April 1, 2018 for the Township of Waterford.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

SECTION I. SEWER RATES

For each residential and non-residential user, the rate shall be fifty-four dollars (\$54.00) per EDU (Equivalent Dwelling Unit) per quarter.

SECTION II. WATER

A. The base rate for water for each residential and non-residential user shall be sixty-two dollars (\$62.00) per quarter.

The water consumption rates will be billed on a quarterly basis as follows:

B. There shall be a quarterly charge for hydrants and private sprinkler systems as follows:

SECTION III.

Should any Section, Subsection, Part, Clause or Phrase of this Amended Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this Ordinance are hereby declared to be severable.

SECTION IV.

All Ordinances or parts of Ordinances that are inconsistent with this Amended Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION V.

This Ordinance shall take effect immediately after final adoption and publication as required by law.
