**ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER 59 OF
THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED
“PURCHASING PROCEDURES, PAYMENT OF BILLS AND PAYROLL”**

WHEREAS, the State of New Jersey has increased the minimum bid threshold from \$36,000.00 to \$40,000.00 for municipalities with Qualified Purchasing Agents; and

WHEREAS, Susan E. Danson serves as the Qualified Purchasing Agent for the Township of Waterford; and

WHEREAS, the Mayor and Township Committee have determined to increase the authority to solicit bids and Request for Proposals by the Qualified Purchasing Agent to \$40,000.00.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Waterford, of the County of Camden, State of New Jersey as follows:

SECTION 1. Chapter 59 of the Code of the Township of Waterford captioned “Purchasing Procedures, Payment of Bills and Payroll” is hereby amended as follows:

Section 2(C) is hereby revised to amend the figure of \$36,000.00 to \$40,000.00.

SECTION 2. All Ordinances or parts of Ordinances which are inconsistent with any provisions of this Ordinance are hereby repealed as to the extent of such inconsistencies.

SECTION 3. If any provisions of this Ordinance, or the application of any such provision to any person or circumstance, shall be held invalid, the remainder of this Ordinance to the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provision of this Ordinance are severed.

SECTION 4.

This Ordinance shall take effect immediately upon adoption and publication as required by law.
