ORDINANCE # 2015-15

**AN ORDINANCE REPEALING CHAPTER 32 OF THE CODE OF THE
TOWNSHIP OF WATERFORD CAPTIONED "BOARD OF HEALTH"
AND REPLACING IT WITH A NEW CHAPTER 32 CAPTIONED
"BOARD OF HEALTH"**

WHEREAS, due to changes in the law, it is necessary to repeal Chapter 32 of the Code of the Township of Waterford captioned "Board of Health" and replace it with a new Chapter 32 captioned "Board of Health".

NOW THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, and State of New Jersey, as follows:

SECTION 1. Chapter 32 of the Code of the Township of Waterford captioned "Board of Health" is hereby repealed and replaced with a new Chapter 32 captioned "Board of Health".

A. Section 32-1 captioned "BOARD CREATED" shall read that the Board of Health of the Township of Waterford shall be known as the Health Services Advisory Board of the Township of Waterford created pursuant to the provisions of N.J.S.A. 26:3-1.

B. Section 32-2 captioned "COMPOSITION"; "Terms of Office" shall read as follows:

"Said Board of Health shall consist of three (3) members who shall be appointed by the Mayor with advice and consent of the Township Committee of the Township of Waterford. The persons so appointed shall be citizens of this State and residents of the Township of Waterford. The terms of office of the three members shall be staggered of not less than one year and not more than three years. Thereafter, all appoints shall be for three-year terms. Vacancies in membership shall be filled for the unexpired term only. Appointment to a vacancy to the Health Services Advisory Board shall be made in the same manner as the original appointment."

C. Section 32-3 captioned "OATH OF OFFICE" shall read as follows:

Each Member before taking office shall sign and file with the Township Clerk an Oath of Office.

D. Section 32-4 captioned "POWERS AND DUTIES" shall read as follows:

"The Health Services Advisory Board of the Township of Waterford shall cooperate with the County of Camden Health Department to provide a program of health services in compliance with the Health Services Act. Further, the Health Services Advisory Board may, from time to time, serve as liaison between the Camden County Health Department and the Mayor and Township Committee of the Township of Waterford in an effort to promote the enforcement of any and all County Health Ordinances. The Health Services Advisory Board shall perform any and all related functions necessary to meet the standards of performances under the Health Services Act".

E. Section 32-5 captioned "DESIGNATION OF COUNTY HEALTH DEPARTMENT AS LOCAL PROVIDER", shall read as follows:

"Pursuant to the provisions of N.J.S.A. 26:3 A2-10, the Camden County Department of Health is hereby designated as the entity responsible for compliance with the Local Health Services Act for any and all functions which would be performed by Local Health Services Provider, including meeting standards of performance."

F. Section 32-6 captioned "COOPERATION WITH HEALTH SERVICES ADVISORY BOARD," shall read as follows:

"The Health Services Advisory Board of the Township of Waterford, County of Camden and State of New Jersey shall cooperate with the Camden County Health Department to provide a program of health services in compliance with the Health Services Act. Further, the Township Health Services Advisory Board may serve as liaison between the Camden County Health Department and the Mayor and Township Committee of the Township of Waterford in an effort to promote the enactment and enforcement of any and all County Health Ordinances."

SECTION 2. All Ordinances or parts of ordinances which are inconsistent with any provisions of this ordinance are hereby repealed as to the extent of such inconsistencies.

SECTION 3. If any provisions of any section, sub-section, paragraph, subdivision or clause of this amended Ordinance shall be judged invalid by a court of competent jurisdiction,

such Order or Judgment shall not effect or invalidate the remainder of any section, sub-section, paragraph, subdivision or clause of this amended Ordinance.

SECTION 4. This Ordinance shall take effect immediately upon adoption and publication as required by law and Certification by the New Jersey Pinelands Commission.


