**ORDINANCE OF THE TOWNSHIP OF WATERFORD,
COUNTY OF CAMDEN, NEW JERSEY CANCELING
CERTAIN FUNDED APPROPRIATION BALANCES
HERETOFORE PROVIDED FOR UTILITY CAPITAL
IMPROVEMENTS AND REAPPROPRIATING SUCH
FUNDED APPROPRIATION BALANCES FOR OTHER
UTILITY CAPITAL PROJECTS**

BACKGROUND

WHEREAS, the Township of Waterford, County of Camden, New Jersey ("Township") duly and finally adopted Bond Ordinance 2014-08 ("Bond Ordinance"); and

WHEREAS, the Township, having completed the project authorized pursuant to the Bond Ordinance, has a remaining balance in the amount of \$148,522.04;

WHEREAS, the Township is desirous of canceling and reappropriating the unspent balances of the project described in the Bond Ordinance for the completion of certain other utility capital projects of the Township as further described below.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WATERFORD, COUNTY OF CAMDEN, NEW JERSEY (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), PURSUANT TO THE PROVISIONS OF THE LOCAL BOND LAW, CHAPTER 169 OF THE LAWS OF 1960 OF THE STATE OF NEW JERSEY, AS AMENDED AND SUPPLEMENTED ("LOCAL BOND LAW"), AS FOLLOWS:

Section 1. The following appropriation remaining as a balance in the Bond Ordinance heretofore adopted by the Township is hereby cancelled:

Section 2. The sum of \$148,522.04, which represents the funded appropriation cancelled in Section 1 hereof, is hereby reappropriated for the completion of various improvements to the Utility System, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto; in the amount of \$148,522.04 (useful life of 20 years) ("Improvements").

Section 3. The period of usefulness of the Improvements referred to in Section 2,


within the limitations of the Local Bond Law and according to the reasonable life thereof, is not less than 20 years.

Section 4. The Capital Budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

Section 5. The Improvements authorized hereby are not current expenses and are general improvements that the Township may lawfully make. No part of the cost of the Improvements authorized hereby has been or shall be specially assessed on any property specially benefited thereby.

Section 6. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.


Section 7. This ordinance shall take effect twenty (20) days after the first publication thereof after final passage.
