ORDINANCE AMENDING ORDINANCE 2012-17 CAPTIONED "AN ORDINANCE ADOPTING RULES, REGULATIONS AND RATES GOVERNING APPLICATION FOR SANITARY SEWER AND WATER SERVICE IN THE TOWNSHIP OF WATERFORD"

WHEREAS, on a periodic basis the Township of Waterford reviews and evaluates the various sewer and water fees that it charges; and

WHEREAS, as a result of this periodic review, it has been determined that certain sewer and water fees should be adjusted.


NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of Township of Waterford, County of Camden, and State of New Jersey as follows:

SECTION 1. The Township of Waterford hereby adopts the following revisions to its sewer and water rate schedule as set forth on Schedule "A" attached hereto and incorporated by reference herein.

SECTION 2. If any provision of this Ordinance, or the application of any such provision to any person or circumstances, shall be held invalid, the remainder of this Ordinance to the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provisions of this ordinance are severable.

SECTION 3. All ordinances or parts of ordinances which are inconsistent with any provisions of this ordinance are hereby repealed as to the extent of such inconsistencies.

SECTION 4. This Ordinance shall take effect immediately upon adoption and publication as required by law.


