ORDINANCE OF THE TOWNSHIP OF WATERFORD, COUNTY OF CAMDEN, STATE OF NEW JERSEY REPEALING ARTICLE II OF CHAPTER 94 OF THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED "HORSES"

WHEREAS, on a periodic basis the Township of Waterford reviews its various Ordinances for any revisions or clarifications to be appropriate; and

WHEREAS, upon review of Article II captioned "Horses" of Chapter 94 captioned "Animals" it has been determined that said Section shall be repealed.


NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

Section 1. Article II captioned "Horses" of Section 94 of the Township Code is hereby repealed in its entirety. All reference to horses is now found in Chapter 176 of the Township of Waterford Code captioned "Land Use, Development and Zoning", Section 48 captioned "Animals".

Section 2. All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

Section 3. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

Section 4. This Ordinance shall only take effect after final adoption and publication as required by law.


