**ORDINANCE NO. 2020-3**

**ORDINANCE OF THE TOWNSHIP OF WATERFORD, COUNTY OF CAMDEN, NEW  
JERSEY APPROPRIATING \$23,327.78 FOR PURCHASE AND ACQUISITION OF  
VARIOUS PIECES OF COMPUTER EQUIPMENT FOR THE TOWNSHIP MUNICIPAL  
BUILDING**

**BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey as follows:

**Section 1.** There is hereby appropriated the sum of \$23,327.78 from the Township Capital Improvement Fund for purchase and the acquisition of various pieces of Capital Computer Equipment for the Township Municipal Building as set forth on the list attached to this Ordinance and incorporated by reference herein.

**Section 2.** It is hereby determined that the said purchases/acquisitions set forth in Section 1 for the Municipal Building are for general capital equipment and are not a current expense of a Township

**Section 3.** The Capital Budget is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency therewith, and the Resolution promulgated by the Local Finance Board showing full detail of the Amended Capital Budget and Capital Program, as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

**Section 4.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**Section 5.** This Ordinance shall only take effect after final adoption and publication as required by law.
