ORDINANCE NO. 2019-4

**ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER 266 OF
THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED
“VEHICLES AND TRAFFIC”**

WHEREAS, the Waterford Township Police Department has reviewed Section 11 of Chapter 266 captioned “Speed” in regard to revising Speed Limits for the various roads in the Township of Waterford; and

WHEREAS, as a result of that review, it has been determined that the existing Section 11 of Chapter 266 captioned “Speed” should be repealed and any and replaced with a new Section 11 captioned “Speed,” as set forth hereinbelow.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

Section 1. Chapter 266 of the Code of the Township of Waterford captioned “Vehicles and Traffic”, Section 11 captioned “Speed” is hereby repealed in its entirety and replaced with a new Section 11 captioned “Speed” which shall read as follows:

All other Township streets not identified in this Ordinance shall have a designated Speed Limit of 25 MPH the entire length of those streets.

Section 2. Upon adoption of this Ordinance, proper regulatory and warning signs shall be erected and maintained to affect the above designated Speed Limits as authorized by this Ordinance.

Section 3. All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

Section 4. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

Section 5. This Ordinance shall only take effect after final adoption and publication as required by law and is also conditioned on any approval required from the State of New Jersey Department of Transportation for any roadways under its jurisdiction or the County of Camden for any roadways under its jurisdiction.
