## ORDINANCE AUTHORIZING AGREEMENT FOR TAX EXEMPTION/ABATEMENT WITH CAPITAL SPORTS FLOORING, LLC, BLOCK 204, LOT 3

The Mayor and Township Clerk are hereby authorized to execute an Agreement for Tax Exemption-Abatement with Capital Sports Flooring, LLC for Block 204, Lot No. 3, for a commercial sports flooring and manufacturing facility located at 2116 Leitz Lane on the official Tax Map of the Township of Waterford pursuant to N.J.S.A. 40A:21-1 et seq., and Township of Waterford Ordinance Nos. O-6-99, O-14-07; O-20-08; O-24-08; O-2009-016; and O-2011-032, as amended.
