**ORDINANCE NO. 2021-18**

**ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER 266 OF THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED “VEHICLES AND TRAFFIC”, SECTION 36 CAPTIONED “RESTRICTED PARKING ZONES”**

**WHEREAS**, American Legion Post #311 Located in the Township of Waterford has requested the placement of a Combat Wounded Parking space and sign on Atco Avenue in front of the American Legion building; and

**WHEREAS**, Atco Avenue is a Camden County roadway which requires the County’s approval for this sign location; and

**WHEREAS**, the Waterford Township Mayor and Committee support and endorse this request by the American Legion Post #311.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

**Section 1.** Chapter 266 of the Code of the Township Of Waterford captioned “Vehicles And Traffic”, Section 36 captioned “Restricted Parking Zones” is hereby amended to read as follows:

D. A restricted parking space is hereby established on Atco Avenue in front of the American Legion Post #311 with an address at 2225 Atco Ave, Atco, NJ.


(1) The use of said restricted parking space is reserved for Combat Wounded Veterans only, and which shall be designated by an an identified Combat Wounded Parking Space and sign.

**Section 2.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**Section 3.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

**Section 4.** This Ordinance shall only take effect after final adoption and publication as required by law and approval by the County of Camden.
