ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING ORDINANCE NO. 2021-10 CREATING A NEW CHAPTER IN THE TOWNSHIP CODE TO IMPOSE A TRANSFER TAX ON THE SALE OF CANNABIS BY LICENSED BUSINESSES OPERATING IN THE TOWNSHIP AND A USER TAX ON CONCURRENT LICENSE HOLDERS OPERATING MORE THAN ONE CANNABIS ESTABLISHMENT

WHEREAS, the Mayor and Township Committee for the Township of Waterford previously adopted Ordinance No. 2021-10 which imposed a Transfer Tax on the sale of Cannabis by certain licensed businesses operating in the Township and a user tax on concurrent license holders operating more than one Cannabis Establishment; and

WHEREAS, it is necessary to amend Section 2-3 of that Ordinance captioned "Imposition of Cannabis Transfer Tax and User Tax".

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

<u>Section 1</u>. A municipal transfer tax is hereby imposed on the receipts of each sale by a licensed Cannabis Business operating in the Township of Waterford at the rate of two percent (2%) of the receipts from each sale by a Cannabis Retailer, Cannabis Cultivator, and Cannabis Manufacturer, and a one percent (1%) of the receipts from a Cannabis Wholesaler.

<u>Section 2</u>. All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

<u>Section 3.</u> If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

Section 4. This Ordinance shall o	nly take effect after final adoption and publication as
required by law and is subject to the regula	ations as promulgated, adopted and as may be amended
approval by the Cannabis Regulatory Com	nmission.
