ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER 266 OF THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED "VEHICLES AND TRAFFIC"

WHEREAS, based on the improvements made by the County of Camden to Atco Avenue, Township Police Chief Daniel Cormaney has recommended that the entire length of Atco Avenue be designated a twenty-five (25) mile per hour speed limit and a no passing zone; and

WHEREAS, the Mayor and Township Committee have reviewed said recommendation and have determined that same should be approved; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

Section 1. Chapter 266 of the Code of the Township of Waterford captioned "Vehicles and Traffic", Section 266-11 captioned "Speed" is hereby amended to read as follows:

<u>Section 2</u>. Chapter 266 of the Code of the Township of Waterford captioned "Vehicles and Traffic", Section 266-34 captioned "No Passing Zones" is hereby amended to read:

NAME OF STREET	LOCATION
Atco Avenue	Entire length from US 30 to Jackson Road

<u>Section 3.</u> All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

<u>Section 4.</u> If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of

judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

Section 5. This Ordinance shall only take effect after final adoption and publication as required by law and uon approval by the County of Camden.
