**ORDINANCE NO. 2022-16**

**ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER 266 OF THE CODE OF THE TOWNSHIP OF WATERFORD CAPTIONED “VEHICLES AND TRAFFIC”**

**WHEREAS**, based on the improvements made by the County of Camden to Atco Avenue, Township Police Chief Daniel Cormaney has recommended that the entire length of Atco Avenue be designated a twenty-five (25) mile per hour speed limit and a no passing zone; and

**WHEREAS**, the Mayor and Township Committee have reviewed said recommendation and have determined that same should be approved; and

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

**Section 1.** Chapter 266 of the Code of the Township of Waterford captioned “Vehicles and Traffic”, Section 266-11 captioned “Speed” is hereby amended to read as follows:

<u>NAME OF STREET</u>	<u>SPEED LIMIT</u>	<u>LOCATION</u>
Atco Avenue	25 mph	Entire length from US 30 to Jackson Road

**Section 2.** Chapter 266 of the Code of the Township of Waterford captioned “Vehicles and Traffic”, Section 266-34 captioned “No Passing Zones” is hereby amended to read:



Atco Avenue	Entire length from US 30 to Jackson Road


**Section 3.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**Section 4.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of

judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

**Section 5.** This Ordinance shall only take effect after final adoption and publication as required by law and upon approval by the County of Camden.
