**ORDINANCE NO. 2023-3**

**ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER 60 OF THE TOWNSHIP CODE CAPTIONED "RECREATION ADVISORY COMMITTEE"**

**WHEREAS**, on a periodic basis the Mayor and the Township Committee of the Township of Waterford review various provisions of the Township Code and in doing so have determined that Chapter 60 of the Township Code captioned "Recreation Advisory Committee" should be amended to provide for additional members.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

**SECTION 1.** Chapter 60 of the Township Code captioned "Recreation Advisory Committee" is hereby amended as follows:

**§60-1** Establishment; Number of Members; Residency; is hereby amended to read:

"There is hereby established a recreation advisory committee composed of nine (9) members and three (3) alternate members, all who shall be residents of the Township of Waterford."

**§60-2** Compensation; Appointment; Township Committee's Role; Vacancies:

"A. All members of the Recreation Advisory Committee shall serve without compensation and shall be appointed by the Waterford Township Committee as follows:

- (1) Three members shall be appointed for an initial term of three years, three members shall be appointed for an initial term of two years and three members shall be

appointed for an initial term of one year. At the expiration of each of the initial terms, each member shall be appointed for a term of three years

- (2) There shall be three alternate members designated as Alternate 1, Alternate 2, and Alternate 3. Each Alternate Member shall have a one-year term.”

**§60-3 Meetings and Officers.**

A. The Recreation Advisory Committee shall meet at least once a month.

B. Roles on the Recreation Advisory Committee

(1) Chairperson: At the first meeting of the year, a Chairperson shall be selected by a majority vote of the members of the committee. The chairperson’s term shall be for one year.

(2) Vice-Chairperson: At the first meeting of the year, a Vice-Chairperson shall be selected by a majority vote of the members of the committee. The Vice-Chairperson’s term shall be for one year.

(3) Secretary: At the first meeting of the year, a secretary shall be selected by a majority vote of the members of the committee. The Secretary’s term shall be for one year. The Secretary shall record the minutes of each meeting. All minutes shall be approved by the committee at a subsequent meeting, and copies of all approved minutes shall be forwarded to the Township Clerk.

**Section 2.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**Section 3.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of

judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

**Section 4.** This Ordinance shall only take effect after final adoption and publication as required by law.
