ORDINANCE # 2023- 16

**AN ORDINANCE OF THE TOWNSHIP OF WATERFORD READOPTING
ORDINANCE NO. 2013-6 AUTHORIZING TAX ABATEMENTS FOR
COMMERCIAL AND INDUSTRIAL PROPERTIES**

WHEREAS, the Township of Waterford adopted Ordinance No. 2000-12 and 2013-6 to provide amendments to Chapter 245 of Code of the Township of Waterford in order to provide Tax Abatements for commercial and industrial properties; and

WHEREAS, in that the terms of said Ordinance indicated that said tax abatement program would no longer be applicable after eleven years following the adoption of the Ordinance; and

WHEREAS, it is the Township of Waterford's intention to continue to offer Tax Abatement for commercial and industrial properties as set forth in said Ordinance amending Chapter 245 of the Waterford Township Code.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

SECTION 1. Ordinance No. 2000-12 and 2013-6 are hereby readopted establishing amendments to Chapter 245 of the Code of the Township of Waterford in order to provide Tax Abatements for qualified commercial and industrial properties.


SECTION 2. All Ordinances or parts of ordinances which are inconsistent with any provisions of this ordinance are hereby repealed as to the extent of such inconsistencies.

SECTION 3. If any provisions of this Ordinance, or the application of any such provision to any person or circumstance, shall be held invalid, the remainder of this Ordinance to

the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provision of this Ordinance are severed.

SECTION 4. This Ordinance shall take effect immediately upon adoption and publication as required by law.
