ORDINANCE # 2023- 23

**AN ORDINANCE OF THE TOWNSHIP OF WATERFORD CONFIRMING
PROVISION OF AMENDING CHAPTER 180 OF THE TOWNSHIP CODE
CAPTIONED “LITTERING”**

WHEREAS, the Waterford Township Environmental Commission has requested the Township’s consideration to increasing the penalty amount to be assessed for a littering violation from One Thousand (\$1,000.00) Dollars; and

WHEREAS, the Township previously adopted an Ordinance increasing all Ordinance penalty violations to Two Thousand (\$2,000.00) Dollars.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

SECTION 1. The Township of Waterford hereby confirms that the penalty provision in the Chapter 180 of the Township Code captioned “Littering” in Section 6 is Two Thousand (\$2,000.00) Dollars.

SECTION 2. The minimum monetary penalty shall be set at Two Hundred Fifty (\$250.00) Dollars.

SECTION 3. All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION 4. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

SECTION 5. This Ordinance shall only take effect after final adoption and publication as required by law.
