- 5. Attach written certification from the Waterford Township Tax Collector that all municipal taxes on the property described in #3 above have been paid.
- 6. Attach a plot plan, prepared by a licensed professional engineer or surveyor, with the date and scale clearly indicated, containing the following information:
  - a. The zoning district in which the property is located.
  - b. The location and dimensions of all property lines, easements affecting the property and streets abutting the property.

- c. The location of all yards and setbacks required by chapter 176 of the Code of Waterford Township.
- d. The location and disposition of all existing structures and improvements on the property.
- e. A building envelope in which the proposed dwelling is to be located.
- f. The location and dimension of the proposed driveway.
- g. The location and dimension of any proposed accessory structures or improvements.
- h. The location and dimensions of the area in which any sewage disposal system, including the drain field, or sewer service line is proposed to be located.
- i. The location of any proposed potable water-well or water service line.
- j. The location of any freshwater wetlands and proposed buffers. If there are wetlands present a 300' buffer is required unless a buffer delineation model is supplied.
- k. Approval box for the Zoning Officials signatures, date and application number.
- 7. If the proposed dwelling will be served by central sewer and/or water, attach written certification from the Waterford Township Municipal Utilities Authority verifying that such service is available.
- 8. If the proposed dwelling will be served by private septic system, attach soil log with profile and depth to seasonal high ground water and show location of boring on plan.
- 9. If the property is proposed to be developed pursuant to section 16 of Chapter 176 of the Code of Waterford Township, the following information must be provided relative to any non-contiguous property that will be utilized in the density transfer.
